Bylaw Changes

The board is considering changing two of our bylaws. Proposed changes in the bylaws are listed below. These changes in bylaws would have to be voted on by the membership at the annual meeting.

Article III, Section 1. The number of Directors shall be nine. Change to seven.

Article V, Secion 1, Directors shall serve a 3-year term.

Article V needs to be clarified regarding how many consecutive terms may be served.

The treasurer has been an exception as changing banks and check signers is somewhat of a problem and not everyone is qualified to be treasurer. Volkmer did a wonderful job being treasurer for at least ten years and only stopped as he felt he needed to step down.

Added language: Directors shall serve a maximum of two consecutive three year terms. They may serve again after one year off. With the exception of the Treasurer, who will hold the position for a time period to be determined and at the discretion of the board.
